**NOTICE WITHOUT OBJECTION OF AUTOMATIC EXTENSION OF TIME  
PURSUANT TO SUPREME COURT RULE 21(6-A)**

NOW COMES Public Service Company of New Hampshire (“PSNH”), by and through its attorneys, McLane, Graf, Raulerson & Middleton, Professional Association, and hereby requests an extension of time to file its brief pursuant to Supreme Court Rule 21(6-A). In support of this Notice, PSNH states as follows:

1. PSNH’s brief in the above-referenced case is due to be filed April 22, 2009.
2. Because of PSNH’s counsel's previously-scheduled work commitments, PSNH respectfully requests that it be permitted a fourteen day extension of time to file its brief in this matter until May 6, 2009.
3. Counsel for PSNH has contacted counsel for Appellants, the Office of Consumer Advocate, Conservation Law Foundation and TransCanada Hydro Northeast, Inc., and each party’s counsel have indicated that they have no objection to relief requested in this motion.
4. Counsel for PSNH did not contact counsel for Campaign for Ratepayer’s Rights, Clean Water Action, New Hampshire Sierra Club, Resident’s Environmental

Action Committee for Health, or Union of Concerned Scientists because those organizations are not yet parties to this case.

5. This is PSNH'S first request for an extension of time in this appeal.

WHEREFORE, Public Service Company of New Hampshire respectfully requests this Honorable Court:

A. Enlarge the time within which PSNH may file its brief by 14 days to May 6, 2009; and

B. Grant such other and further relief as justice requires.


